

ORDINANCE NO. 2019-024

AUTHORIZING THE VILLAGE MANAGER TO ENTER INTO A CONTRACT WITH FED EXCAVATING, INC IN AN AMOUNT NOT TO EXCEED \$49,985 RELATED TO ENLARGING ASPHALT PARKING LOT AT 1400 LYTLE ROAD

WHEREAS, the Village of Waynesville has requested proposals for work related to enlarging the asphalt parking lot to the Government Center at 1400 Lytle Road; and

WHEREAS, FED Excavating, Inc. submitted the lowest and best proposal for said work with a bid of \$49,985.

NOW, THEREFORE, BE IT ORDAINED by the Village Council of the Village of Waynesville, 7 members elected thereto concurring:

Section 1. The Village of Waynesville accepts the specifications and agrees that FED Excavating, Inc. is the lowest and bid bidder.

Section 2. That the Village Manager is hereby authorized to enter into a contract with FED Excavating, Inc. for work related to the service garage driveway.

Section 3. That the Finance Director is hereby authorized to pay a sum not to exceed \$49,985 for said work in accordance with the proposal attached hereto and incorporated herein by reference.

Section 4. That this Ordinance shall be effective from and after the earliest period allowed by law.

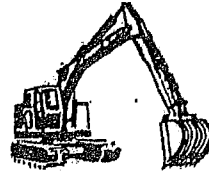
