

ORDINANCE NO. 2019-045

**AUTHORIZING THE VILLAGE MANAGER TO ENTER INTO A CONTRACT WITH BARRETT PAVING MATERIALS, INC IN AN AMOUNT NOT TO EXCEED \$95,000 FOR THE REPAVING OF PRESTON DRIVE AND DECLARING AN EMERGENCY**

WHEREAS, the Village of Waynesville has requested proposals for paving work for Preston Drive;  
and

WHEREAS, Barrett Paving Materials, Inc. submitted the lowest and best proposal for said work with a proposal of \$91,401.25.

5 NOW, THEREFORE, BE IT ORDAINED by the Village Council of the Village of Waynesville, members elected thereto concurring:

Section 1. The Village of Waynesville accepts the specifications and agrees that Barrett Paving Materials, Inc. has submitted the best proposal.

Section 2. That the Village Manager is hereby authorized to enter into a contract with Barrett Paving Materials, Inc. for the repaving of Preston Drive.

Section 3. That the Finance Director is hereby authorized to pay a sum not to exceed \$95,000 for said work in accordance with the proposal attached hereto and incorporated herein by reference.

Section 4. That this Ordinance is hereby declared to be in emergency measure necessary for the preservation of the public peace, health, safety, and general welfare and shall be effective immediately upon its adoption. The reason for said declaration of emergency is the need to authorize the contract at the earliest possible date in order to prevent further deterioration of the street.
